Joel Kurtzberg, Co-Chair of Cahill’s First Amendment & Media Litigation practice group and Chair of Cahill’s Technology, Data Breach, and Privacy Litigation practice group, focuses his practice on general commercial litigation with extensive experience in First Amendment/media law, privacy, insurance/reinsurance, securities law, and antitrust.

Joel frequently appears on behalf of newspapers, broadcasters, journalists, social media companies, technology companies, and others on First Amendment issues and other constitutional matters but has just as regularly appeared on behalf of insurance companies in large coverage and reinsurance disputes and leading companies (and their officers and directors) in securities, antitrust, data breach, patent, employment, and other commercial and intellectual property disputes.

Joel’s legal work has been recognized by the *Financial Times*, *Law360*, *Crain’s New York Business*, *Forbes*, and the *National Law Journal* as being both innovative and effective. In 2025, Joel was named a finalist for the *Financial Times*’ Innovative Practitioner Award and named a *Law360* MVP in the Technology category, for his creative application of First Amendment principles to the challenges faced by technology companies. Also in 2025, he was named to *Forbes*’ inaugural Best-In-State Lawyers list for his work as a commercial litigator. The list identifies the top 36 lawyers in New York State who are considered most preeminent in their specialty. *Crain’s New York Business* in 2025 named him in its first-ever Notable Litigators & Trial Attorneys list, which recognizes the distinguished efforts of lawyers who continuously shape significant legal precedent and zealously advocate for their clients. In 2016, Joel’s work in the closely-watched case *Amarin Pharma Inc., et al. v. Food and Drug Administration, et al.* led the *Financial Times* to rank Cahill as a “Standout” firm in the Changing and Influencing Regulation category of its North American Innovative Lawyers Awards. In 2020, *The National Law Journal* recognized him as a Political Activism/First Amendment Rights Trailblazer, an honor awarded to legal professionals who have “moved the needle” and made a significant mark on legal practice by using litigation to bring about political change and further First Amendment rights. In 2015, *The National Law Journal* named Joel to its “Litigation Trailblazers” list, which recognizes fifty top legal professionals in the United States who have changed the practice of litigation through the use of innovative legal strategies.

Joel has also been ranked by *Media Law International* as a Leading Lawyer in both 2025 and 2026, which is a designation given to the top ten First Amendment litigators in the country. Joel has been recognized as a Local Litigation Star by *Benchmark Litigation* and as “Lawyer of the Year” several times by *Best Lawyers* for his work in

Litigation - First Amendment Law in New York City – an honor bestowed upon a single First Amendment practitioner in New York City each year. In 2020, the *National Press Photographers Association* named Joel a recipient of the Alicia Calzada First Amendment Award, in recognition of his work on behalf of photojournalist Jason Nicholas in *Nicholas v. Bratton*. This award from the NPPA recognizes those who have worked to promote and advance the First Amendment, especially as it relates to visual journalists. *The Legal 500* also recommends Joel as one of the leading commercial and antitrust class action litigators in the country, and *Super Lawyers* ranks him as one of New York's top business litigators.

Joel has been an Adjunct Professor at Brooklyn Law School, where he has taught a class about Mass Media Law. He has also been an Adjunct Professor at Fordham University School of Law, where he has co-taught a class about Internet Law that focuses on First Amendment, intellectual property, and privacy issues in cyberspace.

He was elected to be a member of The American Law Institute in 2007.

Joel is also a "coach" for the Brooklyn Tech High School's mock trial and moot court teams. He has also done a considerable amount of *pro bono* work with Sanctuary for Families, an organization dedicated to serving victims of domestic violence. In 2018, Sanctuary for Families honored Joel with The Abely Pro Bono Achievement Award, which honors individuals who have made a difference in the lives of victims of domestic violence and who embody compassion, zeal, energy, and dedication. In 2003, 2014, and 2015, Joel received awards for Excellence in Pro Bono Advocacy from Sanctuary for Families' Center for Battered Women's Legal Services. He currently serves as a member of Sanctuary for Families' Legal Advisory Committee. Joel has also been named one of the *New York Law Journal's* "Lawyers Who Lead by Example" in 2016 in the Pro Bono category for "an outstanding record of providing crucial legal services to poor or nearly poor New Yorkers."
