## Debt Financing for HCA Acquisition Completed

Cahill represented Citigroup, Banc of America Securities, JPMorgan, Merrill Lynch, Deutsche Bank and Wachovia Securities, as representatives of the initial purchasers, in connection with offerings by HCA Inc., the nation's largest investor-owned health care services provider, of \$1,000,000,000 in aggregate principal amount of 9 1/8% Senior Secured Notes due 2014, \$3,200,000,000 in aggregate principal amount of 9 1/4% Senior Secured Notes due 2016 and \$1,500,000,000 in aggregate principal amount of 9 5/8%/10 3/8% Senior Secured Toggle Notes due 2016, to partially finance the acquisition by Bain Capital Partners, Kohlberg Kravis Roberts & Co. and Merrill Lynch Global Private Equity of the outstanding equity interests of HCA for approximately \$ 33.5 billion and the recapitalization of HCA as a privately held company.
