Proceeds from the offering will be used to refinance certain existing indebtedness of Jabil. In addition, Jabil intends to allocate an amount equal to the net proceeds from this offering to finance or refinance, in whole or in part, one or more eligible expenditures as described in the prospectus supplement relating to the offering, which include expenditures related to eco-efficient products, waste and water diversion, renewable energy, reducing environmental impact of Jabil's operations, green buildings and clean transportation.
