

HCA Completes Amended and Restated Credit Facility

Cahill represented Bank of America, N.A. as administrative agent in connection with the amendment and restatement of HCA, Inc.'s credit facilities, which among other things, extended the maturity date of \$593,786,955 of HCA's term Ioan A facility to May 2, 2016 and the maturity date of \$537,309,995 of HCA's term Ioan A facility to May 1, 2018, and, extended \$1,835,538,851 of HCA's B-1 term Ioan facility to May 1, 2018. Cahill also represented Bank of America, N.A., as administrative agent, in connection with the extension of \$2,000,000,000 of revolving commitments under HCA, Inc.'s credit facility.
