Cahill represented Deutsche Bank, as lead book-running manager, and the co-managers in connection with the Rule 144A offering of €200,000,000 aggregate principal amount of Senior Secured Floating Rate Notes due 2018 by Bitė Finance International B.V. Proceeds from the offering will be used to refinance existing indebtedness and for general corporate purposes.
