
Cahill Secures Dominant Positions Across Capital Markets League Tables for Q3 2020

For Q3 2020 Cahill's Capital Markets & Lending practice achieved some of the highest rankings across several categories in the legal adviser league tables published by *Bloomberg*, *Refinitiv Loan Connector LPC*, and *Debtwire*.

According to *Bloomberg* and *Debtwire*, Cahill captured in excess of 31% of the market share by volume and generated more than \$82 billion in aggregate gross proceeds in connection with high-yield bonds. For loans, Cahill owned more than 34% of the U.S. bank leveraged lending market by volume and generated more than \$128 billion in aggregate gross proceeds according to *Refinitiv LPC* and *Bloomberg*.
