

## Cahill Maintains Unique Market Leader Position With #1 Position in Q3 2023 League Tables for Lender-Side Leveraged Loans & Underwriter HY Bonds

Cahill's Capital Markets and Banking & Finance practices once again secured high ranks across a number of categories for the legal adviser league tables published by *Debtwire*, *Refinitiv Loan Connector LPC* and *Bloomberg* for the third quarter of 2023.


For the eighteenth straight year, Cahill was named the #1 legal adviser to U.S. high-yield bond underwriters by *Bloomberg* with a commanding 27.36% market share.
